

# Dun Laoghaire Rathdown LDTF Workplan 2010

## Updated June 2010

---

### **The Task Force gets its work priorities from 2 key sources:**

1. Its Terms of Reference as outlined in the LDTF Handbook, 2000
2. Key actions in the National Drugs Strategy 2009-2016 where TFs are named among the agencies responsible for their implementation, and that have arisen as a local issue to be progressed.

The key areas of responsibility from the TF's Terms of Reference are:

- Overseeing and monitoring the implementation of projects. The TF has a responsibility to oversee and monitor the activities of the interim funded projects. In Dun Laoghaire, this means that the relevant sub-committee reviews the reports on activities and the financial expenditure from the projects. The TF is also the project promoter of 6 projects. In the case of these projects, the TF has an even greater responsibility in terms of their monitoring and implementation. In addition to the interim projects, the TF links in with mainstreamed projects through the relevant statutory rep. If an issue arises with a mainstreamed project's remit or functioning, the relevant statutory rep should report this back to the TF.
- Updating the area profile to take into account any changes in the drug problem.
- Ensuring that emerging strategic issues are identified and policies or actions are proposed to address them.
- Developing networking arrangements for the exchange of information and experiences with other Task Forces, as well as for the dissemination of best practice.
- Ensuring appropriate representation by the voluntary and community sectors on the Task Force.
- Taking account of and contributing to other initiatives aimed at tackling social disadvantage.

The key actions in the National Drugs Strategy 2009-2016 are identified within each pillar in the workplan.

### **Key external issues for 2010 that will impact on the work of the TF**

- Reduction in the Task Force's global allocation impacting on project's annual funding.
- Development of the NDRIC and role in inter-agency protocols for the treatment rehab sub-committee of the Task Force.
- Inclusion of alcohol and the finalisation of the National Substance Misuse strategy, 2009-2016
- Drugs Advisory Group's work programme regarding the work of the Task Forces:
  - o Revising the Drugs Task Force Handbook;
  - o Developing reporting arrangements for Task Forces to meet the new requirements as set out in the NDS;
  - o Reviewing and renewing the participation and commitment of members of the Task Forces;
  - o Revitalising & supporting the community representation on the Task Forces;
  - o Identifying strategic priorities from the new NDS to be progressed at local/regional level, including input to combined substance misuse policy, and strengthening linkages between non-drug and drug specific "tier 1" services and local policing fora;
  - o Identifying key priorities for Task Force development workers in the areas of community participation, communities of interest, etc and
  - o Reviewing Drugs Task Force boundaries.

It is likely that the OMD will request input into these areas.

In addition, the OMD is likely to request 6 monthly reports on project and TF activities.
